Job Description Summary:

- To carry out under the general direction of the Workshop Management, the planned maintenance, repairs and inspection of the Ports fleet of plant, equipment and vessels.
- To attend to breakdowns of plant, equipment and vessels by:
 - Identifying the faults
 - Operate any available back up systems or equipment where appropriate
 - Carrying out repairs as required
- To take part in the call out roster system to provide adequate engineering cover on a 24/7 basis
- To carry out under the general direction of the Workshop Management other duties as may be required from time to time
- Any other requirements to keep the Port operational at all times

Required Qualifications / Attributes

- Completion of an Engineering Apprenticeship at NVQ L3 or equivalent working experience in a technical capacity
- Extensive experience and knowledge of working on commercial vessels
- A demonstrable knowledge & experience of working on mechanical plant and electrical installations with the ability to diagnose, repair, service and maintain Port assets
- The ability to make use of workshop equipment provided for the carrying out of duties
- The ability to work safely and adhere to safety risk assessments is essential
