

## Poole Harbour Racemarks

**Mariners are advised** that 37 small unlit buoys are laid within the harbour (outside of designated channels) to enable yacht and dinghy racing to take place without unreasonable impact on various other commercial and recreational activities, in line with the [Sail Racing Procedures](#). These racemarks are orange or yellow small plastic buoys clearly marked with their name, and are individually licensed to and maintained by Parkstone YC, Poole YC, Royal Motor YC and PHC as indicated on the chartlet below with positions for the 2025 season. In addition, there are several lit racemarks laid out in Poole Bay that are not regulated by PHC so not included here.
