EXEMPTIONS FROM HARBOUR DUES

- Vessels having no means of propulsion other than oars or sails
- Vessels up to 4.5m in length which are equipped with motors of 5 b.h.p. or less
- Vessels certified by Clubs or the Harbour Master to be Tenders, not exceeding 4m in length. Provided that the Owner has paid Dues on the parent boat and the Tender is permanently marked and used as 'Tender to Parent Boat' and is **NOT** a double purpose boat.

(3) Tender	For definition see Exemptions from Harbour Dues (part C).
(4) Surcharge	Licence fees must be paid by the 30th April or a 25% surcharge will be applied.
